Sub Band to High Band Block Converter

SHC SPECIFICATIONS:

The SHC is a broadband block converter designed to up-convert T7-T14 Sub-band channels to corresponding VHF Channel 7 through 13 and 23 (from T14). The SHC is recommended to be used with a processor, demodulator, or strip amp to re-process the converted T band.


